AMENDMENT TO DECLARATION OF RESTRICTIVE COVENANTS AND DECLARATION OF ANNEXATION FOR MONTE CIELO SUBDIVISION

WHEREAS, RD MONTE CIELO LLC ("Declarant") is the developer of Monte Cielo Subdivision, an addition to the City of Weslaco, Hidalgo County, Texas;

WHEREAS, Declarant previously recorded the Declaration of Restrictive Covenants of the Monte Cielo Subdivision with the Monte Cielo HOA, Inc. (the "Declaration") in the Real Property Records of Hidalgo County, Texas, under Instrument No. 3558696 (the "Original Declaration");

WHEREAS, the legal description of the "Property" subjected to the Original Declaration included all of Lots 1 through 157 and Common Lot(s) "A" and Lot 146, Monte Cielo Subdivision, Phase I, according to the plat recorded under Instrument No. 3558236 of the Map Records of Hidalgo County, Texas;

III. GENERAL PROVISIONS

- 1. Effect of Amendment. Except as expressly amended herein, all terms and provisions of the Original Declaration shall remain in full force and effect.
- 2. **Binding Effect.** This Amendment and Declaration of Annexation shall run with the land and be binding upon all parties having any right, title, or interest in the Subdivision, their heirs, successors, and assigns.
